Motion made by Councilman Reynolds to accept the Minutes of May 14, 2020 with the following additions/changes under Board Comments/Reynolds:

On March 31, 2020 Supervisor Depo met with Councilman Coolidge and Councilman Sauer at an informal meeting to inform them about the water project. Councilman Reynolds claims this is an illegal meeting. Supervisor Depo said it was an error in judgement on his part and took responsibility for the meeting.

Motion to approve the May 2020 Minutes with this addition seconded by Supervisor Depo. All in favor, none opposed, duly passed.

A motion was made by Councilman Reynolds to approve the audited bills for June 2020. This motion was seconded by Councilman McDonald. All in favor, none opposed, duly passed.

# Resolution #061120-2

A motion was made by Councilman Sauer to approve the payment of invoices presented for special projects. Motion was seconded by Councilman McDonald. All in favor, none opposed, duly passed.

### Resolution #061120-3

A motion was made to approve payment of BAR members for 2020 (\$100 per) by Supervisor Depo. This motion was seconded by Councilman McDonald. All in favor, none opposed, duly passed.

# Resolution #061120-4

A motion for a Resolution of Condolence for the family of Thomas O'Neill was made by Supervisor Depo. This motion was unanimously seconded and duly passed. Resolution #061120-5

A motion was made by Councilman McDonald to revise the Policy Manual to further read that employees hired prior to 2009 shall receive their clothing allowance in semiannual payments of \$150 totaling \$300 annually. Employees hired after 2009 will receive a \$300 annual clothing allowance which will be reimbursed upon the presentation of receipts of purchase by employees. Motion seconded by Councilman Reynolds. All in favor, none opposed, duly passed.

# **Board Comments:**

Councilman Reynolds

1. Questions regarding Highway Clerk monthly submissions for mileage reimbursement for delivery/ pick up of inter office correspondence from the Town Office. He requested that DPW employees already traveling every day do the delivery and pick up. After discussion DPW Director Kevin Zaumetzer agreed to do deliveries in the future.

Councilman Sauer

 Voiced concerns about a previous Highway Department spending policy requiring approval from three (3) Councilman for purchased up to \$2500. After discussion, a motion was made by Councilman Sauer to revoke that policy and instead revise it to read that these purchases would need approval from Supervisor Depo. This motion was seconded by Councilman Coolidge. All in favor, none opposed, duly passed. Resolution #061120-12
