VISITORS SIGN REPORT

Councilman Sauer presented the following information regarding the new Visitors Signs;

- 1. First sign structure is up at the Jay Green-drawings to be added in warmer weather
- 2. Second sign to tentatively be placed on Route 9 in Upper Jay on FEMA property
- 3. Third sign is being discussed with Black Brook for placement in a park in their town on Route 9
- **4.** Signs will be a mirror of each other with maps of the three hamlets highlighting the town in which the sign is placed
- 5. Per Councilman Sauer's request a motion was made by Councilman McDonald to approve Councilman Sauer to send a letter of request, along with ideas for placement and sketches to the Department of Homeland Security for approval to place the Upper Jay sign on FEMA buy out property, motion 2nd by Supervisor Depo, all in favor, none opposed, duly passed. *Resolution #031220-7*

BOARD COMMENTS

Councilman McDonald

A question for DPW Director Kevin Zaumetzer regarding the water on the road at the end of Valley Road at the Trumbulls Road end-Director Zaumetzer stated that it was a county road and that he had placed a call to Essex County to report it

DPW REPORT

- 1. DPW Director Zaumetzer reported on his trip to Albany with other DPW Directors to lobby for funding. He reported that the Governor's Office has taken "Extreme Storm Recovery" out of the budget. This will result in an approximate loss to the Town of Jay of about \$18,000-\$20,000.
- 2. A scaled back plan re: gravel crushing to be reported to the board at the next meeting
- 3. DPW Director Zaumetzer thanked the Board for approving the 2020 5 Ton International Truck Bid
- **4.** Clarks Truck Center missed their appointment at the HWY Garage to appraise trucks for trade in
- **5.** As of March 20th all Town of Jay hard top roads have been weight posted at 7 tons–applications for use for vehicles over 7 ton can be obtained at the Highway Garage on Valley Road

AF WATER PROJECT #4487 UPDATE

- 1. Supervisor Depo reported a potential additional \$35,000 in engineering fees from AES to downsize the water project due to Black Brook backing out of the project
- 2. Attorney Manning reported that Black Brook backing out of the project resulted in the loss of 229 users
- 3. Supervisor Depo has been in touch with funding agency representatives to request additional grant funds due to the hardship this has caused the Town of Jay
- **4.** A meeting is being scheduled with Supervisor Depo, Attorney Manning and Essex County Community Resources Director Rob Wick to discuss the downscaling options and funding costs

COMMUNITY CENTER GYM USE

- 1. New Fee and Use policy given to Town Clerk Bea Pelkey to be filed in Town Records
- 2. The policy of requesting insurance from Town of Jay Property users was explained by Attorney Manning

AUDIENCE COMMENTS

- 1. Dave Wiswell (20 Main owner) announced an upcoming fund raiser for the AF Volunteer Fire Department on May 9 at 4:00 pm and invited the Board to attend. Other fundraisers upcoming.
- 2. Audience Member-Concerned about vehicle speed on Route 9 in Jay near the John Fountain Road.
 - **a.** After discussion the Board has requested that DPW Director Kevin Zaumetzer contact NYS DOT for signage
 - **b.** Councilman Sauer made a motion that the Town of Jay request an electronic speed limit monitoring sign (similar to the ones seen in Keene Valley) be placed in the area; motion was 2nd by Councilman McDonald, all in favor, none opposed, duly passed. *Resolution # 031220-8*
- **3.** Audience Member- voiced concerns about certain Town of Jay residents needing intervention from Social Services-Councilman McDonald was aware of the situation and stated that Social Services had already been notified
