## **Application for One-Day Marriage Officiant License**

- The Town Clerk shall issue a one-day marriage officiant license upon request.
- Town Clerk shall charge a fee of \$25 (cash or check).
- The officiant must be 18 years of age or older, valid photo ID required and a copy will be retained with the application.
- The officiant does not need to be a resident of the Town of Jay or a resident of New York State.
- The one-day marriage officiant has the authority to solemnize a marriage as long as it is performed in accordance with other laws of the State of New York. Applicant must provide the exact date and location of the ceremony.
- The one-day marriage officiant has the authority to marry the couple anywhere in New York State.
- The applicant for a one-day marriage officiant license has to apply in the same Town Clerk's Office as where the couple received their marriage license, not where they're being married.
- If the applicant for the one-day marriage officiant license cannot appear in front of the Town Clerk, they need to attach a copy of the marriage license to the application and sign in the presence of a Notary Public.
- Once the one-day marriage officiant license is granted, the officiant may solemnize a marriage anywhere in New York State during the period of time during which the couple's marriage license is in effect.
- Once the marriage takes place, the marriage officiant must file the marriage license with the Town Clerk within five (5) days of the ceremony.
