- Application update: The board was unable to resolve the issue of numbers of copies needed in applications, as sufficient numbers need to be available for board review and public viewing at meetings. Mr. Forbes proposed to work with the board to ensure access and funding for printing. The board needs five paper copies of applications and three maps at board meetings. The availability of electronic copies in advance are useful to the board members and the public.
- Comprehensive Plan: The grant was submitted at the end of July. Mr. Walters discussed next steps, to include the Town Board's approval of a Comprehensive Plan Special Board to be appointed by the Town Supervisor and potentially begin meetings in November.
- Budget: The board reviewed the draft budget proposal and decided it was insufficient, as \$300 additional dollars would be requested for printer capability. All approved the revised proposal: Mr. Pagano motion, Mr. Gillman second.
