- discussion and decision

#### 5. Best Value Solicitation:

- alternative to best price, limited to grant amount; evaluates scope, experience and proposed plan
- requires careful delineation of essential tasks and desirable tasks
- implications: revise RFP & establish means for evaluating proposals
- discussion and decision

# 6. Follow-up Discussion on Vision Development:

- values to vision to goals to actions
- alternative visions of town future
- data gathering needed (e.g., population & housing)
- public input to shape: community workshop
- public input and selections: public hearing

### 7. Public Engagement Plan:

- formal mechanism for gathering public input: how much, how to sequence
- first draft public engagement diagram
- additional methods: brainstorming
- discuss; plan yet to be drafted
