# **Update on Items of Interest**:

- Olivia Dwyer presentation on Recreation Economy for Rural Communities (RERC) grant opportunity: federal planning assistance for smart growth technical assistance to rural communities dependent upon recreational economy; no community contribution required; to boost outdoor recreational economy and revitalize main streets; partnership of EPA, USDA, Northern Border Regional Commission, Appalachian Regional Commission and Denali Commission; application timeline may line up with our comprehensive plan efforts
- Meeting overview: primary goal of preparing for Open House

## **Community Survey Draft 3.0:**

- Survey content finalized; substantial changes from previous draft; thanks to everyone on the board who contributed ideas, edits and recommendations
- Presentation example from AES NE of survey from Jay, Maine
- Survey includes topics of each working group, as well as public safety, and reduced demographic questions
- Board approved content for release to AES NE to put on Survey Monkey; Tim Rowland to provide photos
- Ann Holland described how she can code narratives and interviews
- The group discussed the possibilities of future surveys but deferred any decision to do so
- An extensive discussion was held on how to divide the district geographically for use throughout the update, with decision to use the delineation provided by Supervisor Stanley while recognizing many residents have varying understanding of the boundaries

## **Website Update:**

- Board review of draft website: too hard to read against background, fonts too small. Revisions recommended before release to public. Scott Allen promised changes.
- Board also recommended linking to town website.
- Three initial pages needed: survey, plan description, ways to get involved.
- No limits on access to survey page. Desire to have invite all who have connections to Jay to take survey.
- AES NE to produce post card or handout with QR code and website link to survey.

## **Open House Final Planning:**

- Boards for information, maps and for sticky notes. Sticky note boards will include topics by working group and by geographic sections of the town.
- Emphasis on enabling people to show up at the time of their choice within the window of the Open House.
- Discussion on materials required. AES NE will provide easels and boards.
- Working group leaders to provide content of their boards. AES NE will accomplish the
  making of the boards and improving of their format. Board members reviewed some draft
  content. Discussed importance of keeping content simple, clear and readable. Olivia
  Dwyer will help with editing.
- Importance of having working group members being present and shaping conversations and encouraging public inputs.
- Approach of "Share your ideas and concerns" got lots of feedback in Chesterfield Open House.
- Deadline for submission of content for boards: Tuesday noon, 15 Oct.

- Upcoming presentation to AuSable Acres Property Owners Association and other groups
- Opportunity to give handouts at Open House about what town committees are doing
- Recent TV profile about comprehensive plan
- More announcements to come on Jay Community News
