1. Meeting called to order at 6:30 PM

Motion to approve March 17<sup>th</sup>, 2025, meeting minutes. All in favor and none opposed.

- 2. Jay Visioning Workshop and Summer Events:
- WW: Visioning workshop: updated plan (v. 3.0): now four hours, no lunch, start 9 am, open participation for the public
- MS: concern to keep moving forward; we've slowed down a bit in committees; based on County Strategic Planning Workshop, recommend: deliberate seating, each table answer same questions; each table have a recorder; may need more time to get deeper on issues; may need more meetings to share information with public
- AD: from North Elba experience: invest time; invite breadth of groups so not excluded; importance of prep; North Elba result was 4x4 matrix across affordability vs climate preparation
- SA: ARH and I excited by unique approach, giving options to town board before developing details of plan; trying to filter down options for public rather than just identify goal by general consensus; once have a vision, can focus in on land planning and other issues
- MG: 1980 plan was 'insanely overkill' but none of it happened; 1997 LA Group just lifted material from other plans; 1993 sub-division regs were never updated; 1997 plan doesn't even talk about APA
- WW: by giving public multiple option we listen; what does town board need to make choices; board can select from options or choose differently; may not even give specific choice, but give guidance which narrows what is considered
- OD: let's make sure we reach out to the public broadly; library meetings and more
- Maddie S: four hours is long
- TR: having visions give us something to show to town; 'starter kits'; interconnected implications of surrounding communities to consider at some point

- 3. Discussion of other town methods and status:
- OD: can we see what finished product might look like; what other towns have done
- WW: Dept of State approach does not look at alternatives; process driven by who is grant officer; but we have DEC grant, so we have more flexibility; but DEC just funded 10 comp plans this round; haven't funded others for several years; Dept of State insists on micro-management, therefore Chesterfield took 17 months to have first event
- MG: other comp plans, end products tend to be hard to read
- AD: Alternate vision memos helped me to understand the concept; what we're going to likely get is some amalgamation of options
- MS: a lot of documents have huge portion of 'cut and paste' for conditions; but few pages on key details of town fitting in 'cookie cutter' large document; have to indicate interest in potential grants
- AS: funding agency asks if specific projects are considered in grant application; not just about adopting land regulation; think what we want to do for the town, infrastructure; vision can inform what the town will seek, whether for infrastructure or parks; I'm excited about identifying alternatives; think also what the town wants to pursue for funding
- 4. Approving Visioning workshop:
- AD: I like getting people out of their groups for talking alternative visions
- OD: I'm concerned that we may be missing lots of people and groups
- WW: Need to distinguish visioning workshop from open houses & surveys; visioning workshop is intended to enable lots of public feedback in other events; we need to commit to workshop now if we are to have it, so we can make announcements; I think we're a bit more than a month behind on our timeline; survey very helpful but lot of work to do well
- WW: need to take advantage of the newsletter, including something from each working group; we'll need to more than just have a meeting a month to get things done
- OD: what will have in August? Do we do interviews?
- WW: public input from open houses, survey, meetings, on visions and issues we ask about; try to tune to wants of town board members; lot of work to do interviews and we had list of 50 people, much more than our contract; we didn't do interviews yet since we got so much good feedback earlier; we can save the interviews for late stage, during drafting of the plan
- MG: ultimately, we are the ones at the workshop and beyond who will determine what the public is asked
- TR: we can put out a call to groups with what comes out of the visioning workshop
- MG: we can do that with individuals too
- OD: we need to look ahead to what we're doing after the workshop
- WW: time to call the question on the workshop so we can focus on events like the open house: Are we going to do the workshop or look for an alternative which we won't be doing in May?
- WW: Specific attendee invites would all on town board, CPSB, working groups, and anyone else would be useful, starting with our January stakeholder list; and we invite the public, as this would be a public meeting. It's not just by invitation only. Not everyone who is invited will attend and that's fine.
- MS: I'd like someone else to review the list
- 5. Discussion of workshop logistic details:
- discussion on schedule; agreed to start at 9 am and skip lunch

- OD: I can take on invitations
- SA: We can take on doing a flyer and putting on website; we did this for May 22<sup>nd</sup> for Champlain
- SD: what do we need from working groups prior to 31 May?
- WW: perhaps something short on what's been done; most people in room will only have been involved in only part of process; we'll need some read aheads and crisp, short briefings at beginning
- SA: we can manage the RSVPs
- WW: if we get more people, we'll just handle it; read ahead will go to those who register; I see the 19 May meeting as an opportunity to get ready; maybe even some effort at rehearsal; ARH will be the overall facilitator; we'll iron out details at our next meeting; will have some sort of power presentation at beginning; not sure JEMS has the bandwidth to allow watching remotely
- AD: I think we should not entertain hybrid option. MS: but we should record the meeting
- WW: the video record is very helpful MS: having slideshow could be useful

## 6. Other subjects:

- we didn't get to much of agenda
- St Armand example of community profile in draft by AES-NE; also Willsboro 2011 community profile which ARH worked on; time to get AES-NE started on research; we'll spend money on this; it's an integral part of comp plan; road already built as both examples are in largely same content and format; at some point, we can each mark up to emphasize our own focal topics; no immediate deadline, just looking ahead
- we'll want some brief community profile stuff in the briefing at the workshop, and some build out analysis; SA has already done some work on this; community profile is almost a separate product; some even alongside comp plan rather than within it
- RL: we have a useful community reference guide for services done by Adirondack Enterprise; hope everyone will help spread it around
- Go Around for last comments; recognizing effort in town and CPSB websites
- MG: some STR/LTR conference info documents available on the google drive/external documents; 110 page report by Cornell
- WW: I'll be attending the APA conference on 8 May; hand-out describing study done for APA of how to think about land planning; but as TR noted, the APA doesn't always observe its process
- MS: Thank you. I know I'm putting on the gas.
