- The above fee includes the Town's purchase and installation of a septic tank, lateral from the tank to the main, and service connection to the sewer main itself. The above cost may also include, at the Town's discretion, one or multiple clean-outs, and/or engineering fees if applicable. Upon completion of the installation, the Town shall own, and is responsible for the maintenance of, the septic tank and all components of the lateral leading from the septic tank to the sewer main. Access to the tank for cleaning and inspection shall not be impeded.
- With input from the applicant, the Town will determine the final location and elevation of the tank.
 Under no circumstances will the Town install the tank at an elevation below that which allows for an appropriately pitched sewer lateral leading to the sewer main.
- After tank installation, it is the applicant's responsibility to install or have installed the lateral leading from the influent side of the tank, back to the building being connected to the system. Any part of this section of lateral, including any pumps, lift stations, or force mains required to deliver waste into the septic tank, will be owned and maintained by the applicant.

- The above cost is an estimate, good for 30 days from the date given.
- This application does not supersede or replace any requirement of the applicant as determined by the Town of Jay Code Enforcement Officer. This application is required in addition to, and not in place of, a building permit.
- No connection to the Au Sable Forks Community Wastewater System will be considered without a Town approved, owned, and maintained septic tank in place.
- Any connection to the Au Sable Forks Community Wastewater System will be for residential, household waste ONLY. Any commercial or industrial use requires written permission by the Superintendent of Water/Wastewater, and if allowed, may require special infrastructure or pre-treatment. Failure to comply may incur fines to cover the cost for the cleaning and repair of any down-stream infrastructure or facility negatively affected by the discharged waste, as well as any fines the Town of Jay may be subject to for unlawful discharges to the Ausable River.
- The Town will only perform installation of sewer components from May 1st through October 31st. This application, signed by the applicant, along with full payment, must be returned to the Town no later than 10 business days before the desired installation. Checks should be made out to Town of Jay.
