MINUTES

Town Parks Updates

Upper Jay Parking Lot: Info sign installed with solar light. Brooke has brushhogged the surrounding FEMA parcels and cleaned up trees to open up the area.

Trash cans: Still out. Will be pulled out of parks for storage in November.

Port-a-Potties: Still out in some locations (Children's Playground; The Grove sports fields). Will be pulled out when Youth Commission schedules are done.

New Member Introduction

Frank Krueger: After retiring as a lawyer in Washington, D.C., Frank moved to the Ausable Acres 25 years ago. He has spent that time volunteering with the Adirondack Mountain Club, where he was on the board of directors, chair of the trails committee, and a volunteer Summit Steward for 13 years. He also served on the board of the Adirondack Ski Touring Council, which is now the Barkeater Trails Alliance.

Dog Park Updates

- Larry is still talking to Wendy at North Country SPCA about fiscal sponsorship.
 Larry and Sarah do not want to create a 501(c)(3). Sarah will reach out to
 AdkAction and Adirondack Community Foundation to see if they are able to
 provide fiscal sponsorship. They did raise \$105 in donations at Jay Day.
- At the suggestion of the Town Board, Sarah and Larry are canvassing neighbors of the proposed dog park site at 23 Grove Road. They knocked on 5 doors, spoke to 3 neighbors (all positive about a dog park) and left notes for the other 2

- with no responses. The committee noted that the triplex neighboring 23 Grove Road is owned by Adam Coolidge, who rents to occupants, and suggested reaching out to him as the property owner.
- Sarah spoke to the Au Sable Forks Volunteer Fire Department. They did not
 have any concerns about a dog park impacting their use of the property. Olivia
 suggested requesting a letter of support.
- Larry talked to the Christmas in the Forks committee. They did not have any concerns about a dog park impacting their use of the property. Olivia suggested requesting a letter of support.
- The committee discussed Town Board concerns about dog waste creating more work for Parks employees. Brooke recommended a single unit with bag dispenser and trash unit in one, saying that it worked really well in Wilmington. Sarah shared plans to fundraise for the maintenance, trash pickup, and infrastructure. Larry is committed to volunteering and checking in 3 to 4 times a week. Olivia suggested checking in with the Highway Department to see if dog waste could be put in their dumpster to eliminate cost of an additional pickup spot.
- Olivia will draft a letter that Larry and Sarah could send to nearby landowners to ensure they are fully informed about progress so far.

Comprehensive Plan

Committee discussed tension between interest in more trails and resistance to more outdoor recreation development. Mirrors similar tension between "yes" to more tourism for the purposes of economic development and "no" to more tourism because people want the town to invest in what serves residents, not visitors.

Frank suggested the Town explore a public access easement to trails in Ausable Acres to allow all residents of Jay to use this system.

Recreation Economy for Rural Communities Program

Relate to Comprehensive Plan framework by having one volunteer project in each category:

- 4) Community Programs engage school in students doing a trash pickup

Use locations and projects to help guide partners and sponsorships selections

Other ideas:

- More community engagement: Connect with teachers/advisors in local schools, especially for clubs like National Honor Society that have a community service requirement, and elementary school given Au Sable Forks location.
- 3) Future considerations as outdoor recreation infrastructure expands and more volunteer help is needed:
 - a) Coordinate another project with National Trails Day in June.
 - i) Good time to collaborate with DEC on Jay trailhead and trail.
 - b) Plan for a fall trail day too, as trail work is needed to clean out drainage ditches and clear blowdown this time of year.
